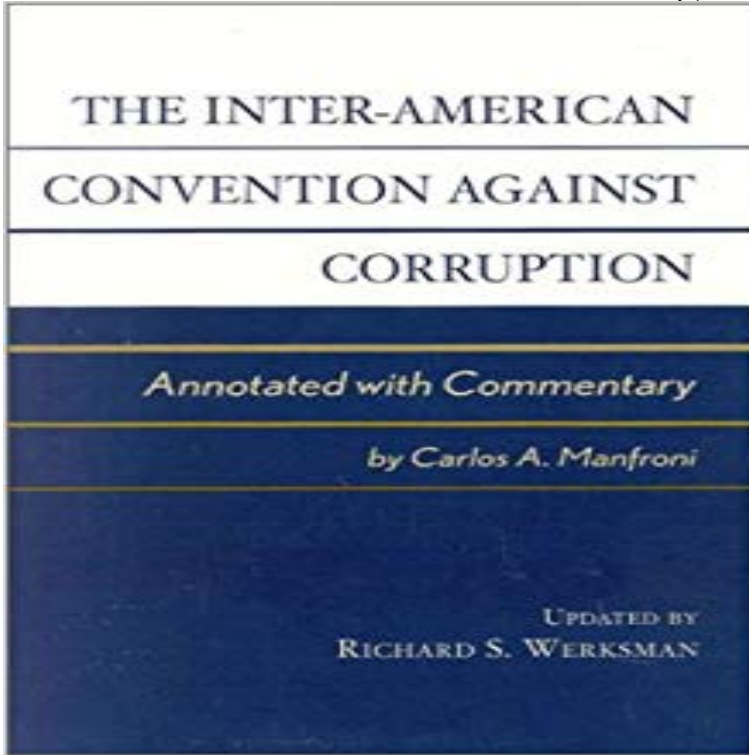


The Inter-American Convention Against Corruption
